1 Summary of Performance

1.A Introduction

This Budget Performance Report for Adamawa State is prepared on quarterly basis and issued within four weeks from the end of each quarter.

This report includes the original approved budget appropriation for the year 2022 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter (i.e. first quarter), attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This first quarter report is assessed against the 2022 Original budget.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Office of the Accountant General in conjunction with the Budget Department, Adamawa State, and published on the Adamawa State website (www.budgetoffice.ad.gov.ng).

1.B Revenue Performance

The State Government budgeted the sum of N163.630 billion as Total revenue for the year 2022. The sum of N105.133 billion being recurrent revenue while N58.497 billion for capital receipts. The State realized the sum of N17.285 billion for recurrent revenue, representing 16.4% and N12.531 billion for capital receipts, representing 21.4%. Overall, the State recorded the sum of N34.529 billion as Total Receipts (including opening balance), representing 21.1% revenue budget performance for the first quarter period ended 31st March 2022. So far, the performance was fair, we are on course to achieving the 100% performance.

1.C Recurrent Expenditure Performance

The recurrent expenditure budget stood at N98.855 billion for the fiscal year 2022. The state recorded a performance of 14.4% having spent 14.224 billion in first quarter of 2022. The actual performance of 14.224 billion is represented by N7.672 billion and N6.552 billion being personnel cost and other recurrent cost respectively.

1.D Capital Expenditure Performance

The approved budget for Capital expenditure for the year 2022 is N64.775 billion. The actual expenditure to date on infrastructure development of the State stood at N3.953 billion.

1.E Conclusions

Overall, the performance of the State Government for period ended 31st march, 2022 is considered fair in terms of revenue generation, and expenditure execution amidst volatile economic conditions.
