#### **AUDIT CERTIFICATE**

#### Responsibility of the Accountant General

#### **Responsibility of Auditor General**

The Auditor General is responsible for undertaking regularity and performance audits in compliance with International Standards of Supreme Audit Institutions (ISSAIs) - "INTOSAI Auditing Standards" and the relevant laws stated in paragraph one (1) above on the accounts of Adamawa State Government. ## 1 Summary of Performance

#### 1.A Introduction

This Budget Performance Report for Adamawa State is prepared on quarterly basis and issued within four weeks from the end of each quarter.

This report includes the original approved budget appropriation for the year 2022 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter (i.e. second quarter), attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This second quarter report is assessed against the 2022 Original budget.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Office of the Accountant General in conjunction with the Budget Department, Adamawa State, and published on the Adamawa State website (www.budgetoffice.ad.gov.ng).

#### 1.B Revenue Performance

The State Government budgeted the sum of N163.630 billion as Total revenue for the year 2022. The sum of N105.133 billion being recurrent revenue while N58.497 billion for capital receipts. The State realized the sum of N17.79 billion for recurrent revenue and N3.0 billion for capital receipts. Overall, the State recorded the sum of N19.8 billion as Total Receipts for second quarter of 2022. The 2022 revenue performance year to date is N56.10 billion (including opening balance). This represents 34.3%. of the total budgeted revenue. The increase in opening balance was a result of a reconciliation made after finalization of the 2021 audited accounts published in June 2022.

#### 1.C Recurrent Expenditure Performance

The recurrent expenditure budget stood at N98.855 billion for the fiscal year 2022. The recurrent expenditure for second quarter stood at N17.32 billion while the expenditure performance year to date stood at N31.55 billion, representing 31.9% against the 2022 original budget. The actual performance year to date of N31.55 billion is represented by N16.13 billion and N15.41 billion being personnel cost and other recurrent cost respectively. A few cases of negative expenditure variances have been recorded. However, Virement process is in place to address them.

#### 1.D Capital Expenditure Performance

The approved budget for Capital expenditure for the year 2022 is N64.775 billion. The actual expenditure to date on infrastructure development of the State stood at N8.49 billion.

#### 1.E Conclusions

Overall, the performance of the State Government for period ended 30th June 2022 is considered fair in terms of revenue generation, and expenditure execution amidst stringent economic conditions.
